－Fast（60 days），free of charge for software快速（60日），免官费

- Protection terms： 50 years 50年保护期

- Source code of the software $\rightarrow$ protected 保护源代码

## 02 Patent protection专利保护

2．1 Invention patents vs Utility models vs Design patents
－Invention patents：new technical solutions or improvements to a product or process，functionality． 20 years of protection．3－6 years of registration procedures．发明专利：产品，方法或者其改进所提出的新的技术方案，20年保护期，3－6年申请注册周期
－Utility models：products with new shape or structural physical features，functionality． 10 years of protection． 6 months－1 year of registration procedures．实用新型：产品的形状，构造或者其结合所提出的适于实用的新的技术方案，10年保护期，半年到1年申请注册周期
－Design patents：the aesthetic aspects of the product，non－functionality． 15 years of protection． 6 months－1 year of registration procedures．

3．3 How to protect trade secrets（5 steps）五步保护商业机密

- Identify and catalogue your trade secrets 识别商业秘密并归类
- Use a combination of physical，technical and contractual barriers 结合使用物理，技术和合同手段保护
－Document trade secret protection measures you take，in case of a dispute later on文件记录所采取的商业秘密保护措施，以防后续争议
－Implement a trade secret protection policy within your company，making sure your employees understand your expectations
在公司内部实施商业秘密保护政策，确保您的员工知悉保护要求
－Consider non－disclosure agreements（NDA）before entering negotiations with third parties在与第三方谈判之前，考虑签订保密协议（NDA）

－Definition of the scope of use of software 软件使用范围的定义
Monitoring of the licensee＇s activities：Prevent unauthorised use of the software监控被许可人的活动：防止未经授权使用软件
－Ensuring the validity of your agreement 确保协议的有效性
Protection of new software code generated：Address ownership issues
保护新生成的软件代码：所有权归属
－Assignments or transfers：Prevent your software from being transferred to third parties without your permission
转让：防止软件在未经许可的情况下转让给第三方

- Termination 合同终止
- Language：including Chinese（and English）语言：包括中文（及英文）

－Ownership 所有权

5．3 Evidence preservation 证据保全
－Notarisation 公证
－Blockchain：Internet courts区块链：互联网法庭
$\checkmark$ Though copyright is automatically granted, you should consider copyright recordal, and prepare documents that establish ownership of copyright in software.
$\checkmark$ Please consult a patent attorney for patent registration.
$\checkmark$ Use the 5 steps to protect the trade secrets.
$\checkmark$ Make sure license agreements are suitable for China and are enforceable against your counterparty.
$\checkmark$ Evidence collection and preservation is essential to enforce your rights in China.
